

Invitation to Bid for

Supply and Delivery of Meter, Kilowatt-Hour Meters, 1 Phase, Class 1, 240V, 60 A, Bottom Connected, Electronic.

1. The **CAMARINES SUR II ELECTRIC COOPERATIVE, INC. (CASURECO II)**, through its BIDS & AWARDS COMMITTEE (BAC), invites suppliers to apply for Eligibility to bid for the Supply and Delivery of Meter, Kilowatt-Hour Meters, 1 Phase, Class 1, 240V, 60 A, Bottom-Connected, Electronic, to wit:

being the Approved Budget for the Contract (ABC) to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2017 revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives IRR-RA 10531.
4. A complete set of Bidding Documents may be acquired by interested bidders from **August 26 to September 14, 2025, from 8:00 A.M. to 5:00 P.M.**, except Saturdays, Sundays, and holidays, if any, and on **September 15, 2025, until 8:30 A.M.**
5. Each Bidding Document may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of **Ten Thousand Pesos (Php10,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
6. **CASURECO II** will hold a Pre-Bid Conference on **September 3, 2025, 1:00 P.M.** at CASURECO II Main Office Board Room, which shall be open only to all interested parties who have purchased the bidding documents.
7. **CASURECO II** shall not be obliged to give any clarifications requested by a prospective bidder who failed to attend the Pre-Bid Conference.
8. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, **on or before September 15, 2025, up until 8:30 A.M.** Late bids shall not be accepted.
9. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **BDS Clause 17**.





10. Bid opening shall be on **September 15, 2025, 9:00 A.M.** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the said activity.
11. **CASURECO II** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
