



Invitation to Bid for

Dismantling and Re-Roofing at Calabanga-Bombon Sub-Office (80.5 m²)

1. The **CAMARINES SUR II ELECTRIC COOPERATIVE, INC. (CASURECO II)**, through its BIDS & AWARDS COMMITTEE (BAC), invites suppliers to apply for Eligibility to Bid for the Dismantling and Re-Roofing at Calabanga-Bombon Sub-Office (80.5 m²), to wit:

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2017 revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives IRR-RA 10531.
4. Interested bidders may obtain further information from **CASURECO II** and inspect the Bidding Documents at the address given below from the date of publication until the deadline of submission of Bids, except Saturdays, Sundays, and holidays,
5. A complete set of Bidding Documents may be acquired by interested bidders from **September 2, 2026 to September 21, 2026, from 8:00 A.M. to 5:00 P.M.**, except Saturdays, Sundays, and holidays, if any, and on **September 22, 2026, until 8:30 A.M.**
6. Each Bidding Document may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of **Five Thousand Pesos (Php5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
7. **CASURECO II** will hold a Pre-Bid Conference on **September 10, 2026, 9:00 A.M.** at CASURECO II Main Office Board Room, which shall be open only to all interested parties who have purchased bidding documents.
8. **CASURECO II** shall not be obliged to give any clarifications requested by a prospective bidder who failed to attend the Pre-Bid Conference.
9. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, **on or before September 22, 2026, up until 8:30 A.M.** Late bids shall not be accepted.
10. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **BDS** Clause 17.





11. Bid opening shall be on **September 22, 2026, 9:00 A.M** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the said activity.
12. **CASURECO II** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
