



Invitation to Bid for

Supply and Delivery of Various Line Hardware Materials, Conductors, and Steel Poles (Consignment Basis)

1. The **CAMARINES SUR II ELECTRIC COOPERATIVE, INC. (CASURECO II)**, through its BIDS & AWARDS COMMITTEE (BAC) invites suppliers to apply for Eligibility to Bid for the Supply and Delivery of Various Line Hardware Materials, Conductors, and Steel Poles (Consignment Basis), to wit:

being the Approved Budget for the Contract (ABC) to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2017 revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives IRR-RA 10531.
4. A complete set of Bidding Documents may be acquired by interested bidders from **September 24 to October 13, 2024, from 8:00 A.M. to 5:00 P.M.**, except Saturdays, Sundays, and holidays, if any, and on **October 14, 2024, until 8:30 A.M.**
5. Each Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of **Ten Thousand Pesos (Php10,000.00) per lot**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
6. **CASURECO II** will hold a Pre-Bid Conference on **October 2, 2024, 9:00 A.M.** at CASURECO II Main Office Board Room, which shall be open only to all interested parties who have purchased the bidding documents.
7. **CASURECO II** shall not be obliged to give any clarifications requested by a prospective bidder who failed to attend the Pre-Bid Conference.





8. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, **on or before October 14, 2024, up until 8:30 A.M.** Late bids shall not be accepted.
9. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **BDS** Clause 17.
10. Bid opening shall be on **October 14, 2024, 9:00 A.M** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the said activity.
11. Any prospective bidder may bid on any of the three (3) lots, or all lots; provided, however, that bid documents to be bought shall depend on the number of lot/s the Bidder intends to place bid.
12. **CASURECO II** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
